FedStar Credit Union Name Change Frequently Asked Question (FAQs)

Why is FedStar Credit Union changing names?

FedStar Credit Union was originally founded to serve federal employees in Brazos County. Today, nearly 60 years later, we don't just serve federal employees. We welcome anyone who lives, works or worships within 10 miles of our office. Unfortunately, the name "FedStar" still implies an association to the federal government. We need a name that better represents our brand as a credit union devoted to all its members and the surrounding community.

Is FedStar Credit Union moving away from its affiliation with federal employees in Brazos **County?**

Not at all! We continue to value and honor the legacy we share with the numerous federal agencies housed in Brazos County and look forward to serving our charter members for years to come.

How will this affect my membership status?

The name change will have no impact on member status.

Will my FedStar Credit Union Debit and Credit cards still work?

Yes. You can still use your current FedStar ATM, debit and credit cards. Sometime in the future, your old cards will be replaced with a card that display the new name and logo.

Can I still use FedStar checks and deposit slips?

Yes. Please continue using your FedStar checks and deposit slips. When you run out of checks or deposit slips, your new ones will display the new name and logo.

Is the management or Board of Directors changing?

No. You'll still see the same friendly folks at all our branches.

Will I have to change automatic drafts and direct deposits?

No. Automatic drafts and direct deposits are routed using the same transit and account numbers as now. These numbers have not changed, so there is no need to update this information.

Is FedStar Credit Union changing ownership?

No. One of the best things about credit union membership is members own the credit union. It will never change ownership!

Will this affect my loans, savings and investments?

The name change will not impact on any of your accounts.
