### Credit Union Performance

Brazos Star Credit Union has maintained a constant deposit base, with an increase in shares by 9.28% in 2020. Total loans increased by 4.93%, but total membership dipped slightly by 0.37%. Total investments increased by 12.24%

Overall, assets increased in the last four years and undivided earnings, commonly called retained earnings of the credit union continue to rise, indicating positive earnings of the credit union.


At the end of 2020, the credit union's asset size was \$ 30,204,972
