BRAZOS STAR LOWERS MINIMUM PAYMENTS DUE ON CREDIT CARDS—People helping people

The credit union knows that it has been a hard year for many people, but we can help. Our members don't have to do anything, it is automatic; there is no action required for existing VISA credit card accounts.

Brazos Star is now reducing the percent due to just 3% of the outstanding principal balance for every account. This is a reduction from 5.00% of the outstanding balance and can be a monthly savings for you! We also offer Balance Transfers at no additional cost to our members and at the same interest rate as for regular purchases. Cash Advances are available to members with no transaction fees and at the same interest rate available on your VISA credit card. If you don't have a Credit Card with the credit union and want to take advantage of the low rates, please visit our website and APPLY online. You can also request an increase your current credit limit and apply to lower your rate conveniently from the website. Visit the site and click the CARDS tab and then select your service.
