### **BOARD OF DIRECTORS ANNOUNCEMENT**

The Nominating Committee of Brazos Star Credit Union have announced the names of volunteer members of the credit union who are willing to serve as Board Members for a three– year term. In the fall, a call for candidates is made. Nominations close on January 3, 2022 and the Nominating Committee then reviews all applications and submits a slate of nominees to the secretary of the board.

Elections for the board of directors are held at the Annual Meeting in April of every year. In 2022, three board positions will be filled. The nominees presented are: Ron Weiman, Ted Peabody, Jr. and Tara Jackson. Mr. Weiman and Mr. Peabody are incumbent board members who are willing to serve another three year term. Tara Jackson is the nominee set forth by the committee to replace long-time credit union board member Patricia A. Buck. There will be no nominations from the floor as there will be only one nominee vetted and set forth to the membership for each position. The credit union membership will elect all nominees presented at the Annual Meeting in April.

Our financial cooperative and our membership benefits from a diverse group of board members. Our seven board members are made up of volunteers who provide oversight and guidance to the operations of the credit union. Board members have the membership's best interest in mind in every decision made.

Nominations for any vacancy may be made by special petition and signed by at least one (1%) of the credit union membership with a minimum of 20 and a maximum of five hundred signatures. The closing date for any special petition filing is 1:00 p.m. on March 1, 2022 at the credit union office. The election will not be conducted by ballot when there is only one nominee vetted and presented by the nominating committee to fill each position.
