### **BOARD OF DIRECTORS ANNOUNCEMENT**

The Nominating Committee of Brazos Star Credit Union has announced a call for candidates of volunteer members of the credit union who are willing to serve as Board Members for a three—year term. **Nominations will close on January 13, 2023.** The Nominating Committee will review all applications and will submit a slate of nominees to be announced by the Board Secretary.

Elections for the board of directors are held at the Annual Meeting in April of every year. In 2023, two board positions will be filled. Position 1, is held by Fred Bingaman and Position 2, held Jubal Hancock. Both are incumbent board members who are willing to serve another three-year term. There will be no nominations from the floor as there will be only one nominee vetted and set forth to the membership for each position. The credit union membership will elect all nominees presented at the Annual Meeting on April 13, 2023.

Our financial cooperative and our membership benefits from a diverse group of board members. Our seven board members are made up of unpaid volunteers who provide oversight and guidance to the operations of the credit union. Board members have the membership's best interest in mind in every decision made.

Nominations for any vacancy may be made by special petition and signed by at least one (1%) of the credit union membership with a minimum of 20 and a maximum of five hundred signatures. The closing date for any special petition filing is 1:00 p.m. on **February 28, 2023** at the credit union office. The election will not be conducted by ballot when there is only one nominee vetted and presented by the nominating committee to fill each position.
